Ensuring Rights and Social Security for Gig and Platform Workers

The gig and platform economy has emerged as a significant contributor to the modern labor market, offering flexibility and income opportunities to millions of workers. However, the lack of formal employment status has left these workers vulnerable, without access to social security and basic labor protections. This calls for comprehensive policy reforms to safeguard their rights and ensure equitable working conditions.

The recognition of gig and platform workers as employees rather than independent contractors, granting them access to benefits like provident fund (PF), Employee State Insurance (ESI), and retirement schemes is the need of the hour. The establishment of tripartite boards involving workers, employers, and Government is essential to address employment terms and social security needs effectively. Additionally, an inclusive digital ecosystem should be developed to enable universal worker registration, transparent management, and portability of social security benefits.

It is important to ensure minimum wage guarantees, limit platform commissions, and provide health, maternity, and retirement benefits to workers. Improved working conditions, such as workplace safety and overtime compensation are vital, along with urban infrastructure support like drinking water and electric vehicle (EV) charging stations. Transparency in algorithmic decision-making is critical to protect workers from unfair practices such as algorithm-based terminations and biased customer ratings.

In order to strengthen worker protection, the establishment of robust grievance redressal mechanisms and platforms for collective bargaining is imperative. Funding for social security can be achieved through contributions from central and state Governments, employers, and Corporate Social Responsibility (CSR) initiatives. Platforms like e-Shram can be leveraged for universal worker registration, ensuring seamless data management and social security deductions. Moreover, skill development programs and standardized onboarding processes will enhance workers' career prospects and long-term sustainability.




