About 63 participants, who are CEOs/CMDs/Chairmen of Telangana Urban Cooperative Banks attended the workshop.

The workshop was inaugurated with keynote addresses by distinguished speakers. Dr. S. Glory Swarupa, Director General of ni-msme, emphasized the importance of financial inclusion and urged UCBs to leverage ni-msme facilities to foster MSME lending.

Mr. M.V. Kameswara Rao, Vertical Head - CFI while welcoming the participants, stressed on quality of loan appraisal and role of CFI in capacity building of UCBs for lending to MSMEs.

Shri Nimesh Gandhi, Director of TransUnion CIBIL, presented on credit risk assessment, early warning systems, and digital lending solutions for MSMEs. The workshop concluded with a panel discussion involving UCB representatives and experts, addressing challenges, opportunities in the MSME lending space, and a vote of thanks by Mr. M V Kameswara Rao, Vertical Head of CFI. The event was a resounding success, providing valuable insights, fostering networking, and strengthening the collaboration between UCBs, regulators, and other stakeholders.

Career Progression In-Service Training Program for IEDS Officers (Batch-4)

National Institute for MSME (ni-msme) has organized two-week Career Progression In-Service Training for Indian Enterprise Development Services (IEDS) Officers (batch-4), sponsored by O/o DC-MSME, Ministry of MSME, Government of India from 11 to 22 November 2024 at Pune to enhance the Capacity Building of Officers for effective functioning at workplace and also to support for the growth of



MSMEs. A total of 38 IEDS officers from 18 states have attended the program. The objective of the training program is to develop and refine the skills of officers and allows them to stay updated with the latest methodologies, technologies and best practices relevant to their field of work. The training assists the officers in adapting to changes in policies, regulations and technology. It equips them with the knowledge needed to implement new initiatives effectively and efficiently. During the inauguration, Dr. E. Vijaya, Faculty Member & Program Director, ni-msme gave a brief overview about two weeks training program.

Director General, ni-msme enlighten the participants about the responsibilities of IEDS officers under various schemes of Ministry of MSME and also the need for capacity building of officers to understand the industry best practices for the promotion and development of MSMEs. The training sessions focused on Industry best practices, Quality Management, ESG Initiatives, Digital Transformation, Emerging Technologies, policy updates, MSME Schemes and programs, Procurement portals, Administrative & Financial matters, e-Office Management and Management skills. ni-msme Faulty and Senior Officials from Govt.of Maharashtra, Eminent speakers from Symboisis, VAMNICOM, DIAT, GeM, SIDBI, Senior Lawyers, experts from Industry had handled the sessions during the training. Valedictory session was scheduled on 22 November, 2024. During the valediction, the officers shared their experiences & learnings from the training program. At the end of the program, participation certificates were awarded to the Officers.

Financial Research and Innovation for Sustainable Enterprises (FinRISE)

The Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) scheme was launched in 2000 by the Government of India in collaboration with the Small Industries Development Bank of India (SIDBI). It offers credit guarantees to financial institutions that provide loans to Micro and Small Enterprises (MSEs) without requiring collateral or third-party guarantee. The scheme aims to support first-generation entrepreneurs by providing credit guarantee funding for loans up to INR 2 crores. Launched in 2000, the CGTMSE scheme offers credit guarantees to financial institutions that offered credit facilities up to Rs. 2 crores has now been raised to Rs. 5 crores. CGTMSE scheme offers credit guarantees from 75% to 85% to MSEs across India.

Credit Guarantee refers to a situation where the loan to the applicant is backed by a party without the need for any external collateral or third-party guarantee. Here, the loan sanctioned by the member lending institution is backed by the scheme which provides the guarantee cover for a large portion of the loan amount. Under the CGTMSE scheme, both new and existing micro and small enterprises, including manufacturing and service enterprises are eligible for a credit facility of up to Rs. 5 crores.

Benefits of CGTMSE Scheme

- Ceiling for Guarantee coverage raised from Rs. 200 lakh to Rs. 500 lakh
- Guarantee fee reduced to diminish the overall cost of borrowings to MSEs
- Micro Finance Institutions as Member Lending Institutions (MLIs) are now eligible
- Concessions related to fees and increased coverage to SC/STs
- Reduced Guarantee fee by 10% and coverage extent increased to 85% to Women, ZED
 Certified Units and Units in Aspirational Districts
- Annual Guarantee Fee structure revised and fee reduced to as low as 0.37%

Lending Institutions offering funds under CGTSME Scheme

- Scheduled Commercial Banks (SCBs)
- Regional Rural Banks (RRBs)
- Small Finance Banks (SFBs)
- Non-banking Financial Companies (NBFCs)
- Small Industrial Development Bank of India (SIDBI)
- National Small Industries Corporation (NSIC)
- North Eastern Development Finance Corporation Ltd. (NEDFi)

Small and Micro-Enterprises owned and/or operated by Women Entrepreneurs are eligible for a Guarantee Cover of 80%, whereas all the credit/loans in the North East Region (NER) for credit facilities are eligible for a guarantee of Rs. 50 lakh.

National Institute for MSME (ni-msme) has established FinRISE under Centre of Financial Inclusion (CFI) to create awareness; build the capacity of all stakeholders and carry out policy research for the benefit of MSMEs. The readers may approach ni-msme for further information.

PMKVY 4.0 Special Project in NER

ni-msme is conducting Skill Development Programmes under PMKVY 4.0 Special Projects in Northeast region, namely Assam, Meghalaya, Tripura, Mizoram, Nagaland and Arunachal Pradesh sponsored by the National Skill Development Corporation (NSDC). By focusing on these targeted sectors, the PMKVY 4.0 Special Project fosters both self-employment and wage employment opportunities. The program curriculum is designed to offer practical, hands-on training that equip participants with the skills they need to thrive in these roles. Medicinal and Aromatic Plants Grower (AGR/Q0901), Organic Grower (AGR/Q1201), Bamboo Work Artisan (HCS/Q8702). By the end of November 2024, a total of 5,036 candidates enrolled for the trainings. Certificates were issued for 32 batches, assessments completed for 39 batches, and 68 batches have completed their programmes.



PMKVY 4.0 Short Term Training

. ni-msme is conducting Skill Development Training under the PMKVY 4.0 Short Term Training Programme on campus. By the end of November 2024, a total of 960 candidates had enrolled in trades such as Junior Software Developer, Cloud Application Developer, Beauty Therapist, self-Employed Tailor, and Craft Baker. Certificates have been issued for 8 batches, assessment completed for 8 batches, and 10 batches. A total of 300 candidates have completed their programmes.
