Mekong-Ganga Cooperation

The Mekong–Ganga Cooperation (**MGC**) takes its name from the Ganga and the Mekong, two large rivers in the region. The Mekong River is one of the world's greatest rivers, flowing through six countries: China, Myanmar, Thailand, Lao People's Democratic Republic, Cambodia, and Vietnam. The Lancang, sometimes known as the Mekong River, is a river that rises in China's Himalayas. It travels through nations in the Lower Mekong Basin before entering the South China Sea. The Mekong River flows from the Tibet Plateau to the South

MGC aims at developing closer relations and better understanding among the member-countries to enhance friendship, solidarity, and cooperation; facilitating inter-state movement and transit; transport of goods and people in the region;

creating necessary infrastructural facilities in the Ganga-Mekong basin areas and

encouraging active participation in poverty eradication.

The **MGC** was established on November 10, 2000, at Vientiane, Laos at the First **MGC** Ministerial Meeting. It comprises six member countries, namely India, Thailand, Myanmar, Cambodia, Lao PDR and Vietnam. The **MGC** promotes cooperation in ten priority areas. It was decided that each area of cooperation would be coordinated through an Expert Working Group (WG) led by one **MGC** country. There were five initial Working Groups (WGs) under **MGC** with their lead countries, as follows:

- WG on Tourism: Thailand
- WG on Education (Human Resource Development): India
- WG on Culture: Cambodia
- WG on Communication & Transportation: Lao PDR
- WG on Plan of Actions: Vietnam

In addition, it envisions project-based cooperation among member countries in a variety of fields such as public health and traditional medicine, agriculture & allied sectors, water resources management, science & technology, MSMEs, skill development, capacity building, and the Quick Impact Projects Scheme. The Lead Country would be responsible for giving inputs related to their WG and identifying suitable action points in preparation for Plan of Actions (PoAs). It will also be responsible for providing guidanceon implementing specific projects under the MGCPoA, so as to enhance cooperationin such areas among the MGC countries.

Education

India annually offers scholarships to the **MGC** nations through bilateral and multilateral channels. It is conceivable that Mekong nations have more extensive market access in India than India in **MGC**. Agriculture, processed foods, machinery, electrical and electronics, travel and tourism, and education have all seen significant advancements. Utilisation of students from the Mekong countries by promoting 50 MGC scholarships offered by the Indian Council for Cultural Relations (ICCR). 10 scholarships offered by the Ministry of AYUSH for students interested in pursuing under-graduate/postgraduate/Ph.D in Ayurveda, Unani, Siddha, Homeopathy and Yoga.

National Institute for MSME (ni-msme) organized an International Programme on "Innovation, Market Access, Software Training and Online Payment System for MSMEs Development" under Mekong-Ganga Cooperation (**MGC**) under ITEC scheme of Ministry of External Affairs (MEA), Govt. of India. A total of 19 International Executives from 4 countries, Cambodia, Lao PDR, Myanmar and Vietnam attended the programme. ni-msme Faculty, Industry experts, entrepreneurs, delivered sessions on Digital Transformation in India, UPI Payment System, Blockchain Technology, Payment System Development, etc. Participants were introduced to a range of topics, including the fundamentals of block chain technology, UPI, RUPAY, and the credit and debit system in Indian markets. Study visits to T-Hub, T-Works, NABARD, CDAC, SIDBI, IDRBT, PNB were organized for exposure,interaction and exchange of ideas for improving the digital infrastructure and digitalizing in MGC countries. The programme also included presentations by participants on their learnings, key takeaways, and action plan to be implemented at their workplace. The delegates applauded the programme learnings and efforts of ni-msme in organizing the same. ni-msme is poised for organizing more capacity building programmes on contemporary issues for promotion of Entrepreneurship and MSMEs.
